- 5. Changing and removing personal information
- 5.1. The user may at any time modify or delete the personal information provided by him or her part by sending a relevant notice to the email address info@gbs-broker.ru.
- 5.2. The information will be changed or deleted within 3 working days.
- 6. Measures used to protect the User's personal information
- 6.1. The site administration undertakes to take all necessary sufficient organizational and technical measures to protect the User's personal data from unauthorized access or disclosure.
- 7. Changing the Privacy Policy
- 7.1. The site administration has the right to make changes to this Privacy Policy. When making changes to the current version, the date of the last update is indicated.
